Subject: Altri: demerger of Ramada.

Effective date: 16 June 2008

Action: On Wednesday 16 April 2008 Altri (ISINcode PTALT0AE0002) announced the demerger of Ramada, whereby Altri shareholders will receive 0.25 Ramada share for each Altri share held.

Under the condition that the demerger is carried through, the ex-date for this demerger is expected to be Monday, 16 June 2008 and the PSI 20-index will be adjusted accordingly.

Based on turnover calculations Ramada will not qualify to be included in the PSI 20-index. Altri will stay part of the index. The theoretical adjusted close price for Altri and the resulting new divisor for the PSI 20-index will be announced in a separate announcement on Friday, 13 June 2008, after trading hours.

Acção: Na quarta-feira, dia 16 de Abril de 2008 a Altri (ISIN PTALTOAE0002) anunciou um projecto de cisão-simples, no âmbito do qual é constituída uma nova sociedade comercial – a F. Ramada – Investimentos, SGPS. De acordo com este projecto, cada accionista da Altri receberá 0.25 acções da F. Ramada por cada acção da Altri detida.

Se o processo de cisão-simples se concretizar, espera-se que as acções da Altri sejam negociadas ex-direitos com data efectiva de 16 de Junho de 2008. O Índice PSI 20 será ajustado.

Com base no valor negociado das acções da Altri no último ano a Altri mantém-se no índice PSI 20 mas a F. Ramada não será incluída no Índice PSI 20.

O preço teórico ajustado de fecho das acções da Altri e o resultante novo divisor para o Índice PSI 20 serão anunciados na sexta-feira, 13 de Junho de 2008, após o fecho do mercado.
